

What to do if my bank account has changed?

Send us a certificate of banking details (RIB)

In case of direct debit:

Add the completed and signed SEPA Direct Debit Mandate form to the certificate of banking details, downloadable on cmcm.lu

→ comptabilite@cmcm.lu



The payment method no longer suits me, what options do I have to pay my contribution?

- Monthly, semiannual or annual direct debit payment (direct debit on the 2nd day of the month)
- By PAYCONIQ
- By bank transfer

How do I add coverage?

Send the "Optional benefit plans" form, downloadable on cmcm.lu, or fill it in directly on cmcm.lu

DENTA & OPTIPLUS without PRESTAPLUS?

No, because there are 3 different coverages. Here are all the possibilities:

- -RÉGIME COMMUN (RC)
- -RC + PRESTAPLUS (PP)
- -RC + PP + DENTA & OPTIPLUS

Who is eligible for comembership?

- Married or civil partner.
- Children/parents/relatives who are co-insured with your health insurance company

N.B.: THE CMCM OFFERS UNMARRIED RESP. NON (PACSED) PARENTS THE FREE-DOM TO COAFFILIATE THEIR CHILD(REN) WITH THE PARENT OF THEIR CHOICE;

All you have to do is send us a letter signed by both parents accompanied by a copy of your ID card



Do I need to request a certificate for my tax return?

No, you only need to indicate the amount of your contribution for your tax return including proof of payment

Why did my contribution increase from last year?

The contribution is adjusted annually according to semiannual average of consumer price indexes as per September 1st of the previous year

Can I request comembership for my partner if we live together?

No, it is only possible in case of marriage or partnership (PACS)

What should I do if I change my address?

Send an extended residence certificate /household composition issued by your municipality of residence, or a "déclaration sur l'honneur" (for residents in France)

Below is a list of documents to be provided if your family situation at the CMCM is not complete:



In case of birth, adoption, marriage or partnership (PACS) a copy of the official relevant certificate



If you are studying a certificate of studies from the age of 19

In case of educational/ professional inactivity

a coinsurance certificate from your health insurance



In case of divorce/dissolution of a partnership (PACS)

an extract of the marriage certificate with the entry of marriage dissolution or a certificate of dissolution of a civil partnership (PACS)



In case of death a copy of the death certificate
