

## RÉGIME COMMUN

### **MEDICAL COSTS**

Reimbursement for **medical consultations and examinations** related to surgery or serious treatment, after the health insurance contribution, up to **€25** within 90 days before and 180 days after the treatment.

### **ORTHOPAEDIC FOOTWEAR**

Coverage of costs for orthopaedic footwear approved by the health insurance, up to a **maximum amount of €150** (instead of a maximum amount of €100).

### **CARDIOLOGY**

Contribution to the co-payment of a stress test approved by the health insurance, up to a **maximum amount of €25** per calendar year (instead of a maximum amount of €15).

### **ALTERNATIVE MEDICINE**

**!Osteopathy, chiropractic care, and new benefits for acupuncture and laser therapy!**

Coverage of alternative medicine treatments up to **€50 per session, with an overall annual limit of €100** per calendar year for all such treatments combined.

## PRESTAPLUS

### **ORTHOPAEDIC INSOLES**

Coverage of costs for orthopaedic insoles, duly approved by the health insurance, up to a **maximum amount of €150** per year (instead of a maximum amount of €50).

### **PSYCHOLOGICAL SUPPORT**

Coverage of psychological care for children under 18 years of age, up to a **maximum amount of €100** per calendar year (instead of a maximum amount of €75).

### **ALTERNATIVE MEDICINE**

Coverage of alternative medicine treatments up to **€50 per session, with an overall annual limit of €100** per calendar year for all such treatments combined.



## DENTA & OPTIPLUS

### **DENTAL CARE**

Coverage of pulpctomy treatment up to an **annual maximum limit of €100** per covered person (instead of a maximum amount of €75).

### **CONSERVATIVE AND ENDODONTIC TREATMENTS**

Coverage of the remaining costs of conservative and endodontic treatments up to an **annual maximum amount of €125** per covered person (instead of an annual maximum amount of €100).

### **PERIODONTAL TREATMENT**

Coverage of periodontal treatment, including the root scaling and the periodontal pocket disinfection, up to twice per year, at €100 per session, and surgical treatment with an **annual ceiling of €700** per covered person (instead of an annual maximum of €500).


### **DENTAL PROSTHESES**

Coverage of dental prostheses up to an **annual maximum limit of €3,500** per covered person, excluding temporary prostheses and subject to the application of per-act limits (instead of an annual maximum limit of €3,000).

### **DENTAL IMPLANTS**

Coverage of dental implant procedures and related implantology costs, at a **flat rate of €500** per implant, with an **annual maximum limit of €2,000** per covered person (instead of an amount of €400 per implant with an annual maximum of €1,600).
